

To transition at-risk individuals and families from poverty to self-sufficiency through our agency programs and public/private partnerships.




#### **Vision**








### **Enrollment by Eligibility Type**

## **Community Action Network**

#### **The Promise of Community Action**

Community Action changes peoples lives, embodies the spirit of hope, improves communities, and makes America a better place to live. We care about the entire community, and we are dedicated to helping people help themselves and each other.



#### **Low Income Home Energy Assistance Program (LIHEAP)**

LIHEAP is a federally funded program that assists high-energy burdened, low-income households with the costs of heating and cooling their homes. LIHEAP helps clients stay warm in the winter and cool in the summer through the Home Energy and Crisis Energy Assistance Program.



#### **Community Services Block Grant Program (CSBG)**

CSBG provides federal funds to designated local governments and nonprofit agencies called community action agencies, also known as local agency providers, to assist eligible incomequalified households with attaining the skills, knowledge and motivation necessary to achieve self-sufficiency.



#### Funding allows us to run these programs:

- REACH & Family Self-Sufficiency Program
- Emergency/Rental/Mortgage Assistance
- Food Assistance

## REACH Family Self Sufficiency Program

"REACH helps put an end to generational poverty one family at a time."

The REACH Family Self-Sufficiency Program is an employment training program that provides:

- individual & family case management
- money management
- education
- short-term vocational training.

Clients living at or near the poverty level learn to recognize their barriers to self-sufficiency and how to overcome them. The REACH Program helps determined, hard-working people, achieve their educational and vocational goals, earn a living wage, and move away from poverty and public assistance to financial self-sufficiency.



### LIHEAP



The Low Income Home Energy Assistance Program (LIHEAP) assists high-energy burdened, low-income households with the costs of heating and cooling their homes. LIHEAP, which is federally funded, helps clients stay warm in the winter and cool in the summer through the Home Energy and Crisis Energy Assistance Program.



#### Home energy funds are:

- provided once per calendar year, directly to the utility provider
- based on the client's gross income and household size

#### **Priority target groups include:**

- age 60 or over
- persons with a disability
- at least with one child under 5 (five) in the home



# **Emergency Assistance** (Rental, Mortgage & Food)

The Emergency Assistance Program provides assistance with rent, mortgage, food, and obtaining a Florida ID Card.

For many, the way out of poverty begins with a decision to live a new way. For others, an emergency has resulted in a no-way-out situation. But, for all who want to strive for economic self-sufficiency, the Economic Opportunities Council is here to help. We work to cure the root causes of poverty, not just treat the symptoms.


