4b (Code:) (Expenses \$ 1,706,746 including grants of \$) (Revenue \$) The Low Income Home Energy Assistance Program (LIHEAP) helps low-income households meet the costs of cooling/ heating their homes. LIHEAP offers 2 programs: Home Energy and Crisis Energy. Home Energy funds are provided once a year and are based on the client's gross income and household size. Crisis funding is available when a client experiences a financial crisis. It helps keep electricity on, or restores it if needed. In the 2022 fiscal year, EOC assisted over three thousand households with utility assistance.

4c (Code:) (Expenses \$ 459,224 including grants of \$) (Revenue \$) Community Service Block Grants The REACH Family Self-Sufficiency Program helps put an end to generational poverty one family at a time. It provides education and vocational training. Clients living at or near the poverty level learn to recognize their barriers to self-sufficiency and how to overcome them. REACH helps clients achieve their educational and vocational goals, earn a living wage, and move away from poverty and public assistance to financial self-sufficiency. In the 2022 Fiscal year, EOC successfully support over nine hundred people with rental, utilities, education and other career preparation expenses.
