4b (Code: ) (Expenses \$ 2,092,085 including grants of \$ ) (Revenue \$ ) The Low Income Home Energy Assistance Program (LIHEAP) helps low-income households meet the costs of cooling/ heating their homes. LIHEAP offers 2 programs: Home Energy and Crisis Energy. Home Energy funds are provided once a year and are based on the client's gross income and household size. Crisis funding is available when a client experiences a financial crisis. It helps keep electricity on, or restores it if needed. In the 2022 fiscal year, EOC assisted over three thousand households with utility assistance.
